

TENDER NOTICE

Djibouti Supreme Court construction and equipment project

1. The Government of the Republic of Djibouti has received funding from the Saudi Fund for Development on behalf of the Ministry of Justice, Penitentiary Affairs and Human Rights, to finance the Djibouti Supreme Court Construction and Equipment Project, and intends to use this funding to make payments under the Djibouti Supreme Court works contract.
2. The Djibouti Ministry of Justice, Penitentiary Affairs and Human Rights is inviting sealed bids from eligible and suitably qualified bidders for the construction of a Supreme Court. The work will be carried out in a single lot, as described below:

Contracts resulting from this invitation to tender will be awarded based on unit prices.

3. The bidding procedure will be a restricted Invitation for Saudi contractors or a Joint-Venture between Saudi and Djiboutian contractors, to Tender as defined in the Procedures for the Procurement of Goods, Works and Related Services under Projects financed by the Saudi Fund for Development and open to all eligible bidders as defined in the Guidelines. Prospective bidders are also invited to familiarize themselves with the SDF's rules on conflicts of interest.

Payment will be made in cash. The tender documents may be obtained from the above address.
6. Tenders must be submitted to the General Secretariat of the Ministry of Justice, at the address below, no later than Wednesday June 19th, 2024 . **at 8.00 am** Universal Time. Electronic submission of bids will not be permitted. **Late bids will not be accepted.** Tenders will be opened in the presence of representatives of tenderers who wish to be present at the opening at the PMU meeting room, located at:

7. Tenders must be accompanied by a bid guarantee issued by a bank, financial institution or third party approved by the Djibouti Ministry of Economy and Finance in charge of industry or issued by a bank approved by the Saudi Arabian Ministry of Finance for an amount of :

This bid guarantee will remain valid for 28 days after the expiry of the bid validity period, i.e. **ONE HUNDRED AND FORTY - EIGHT days (119 days + 28 days = 148 days)** from the deadline for submission of bids.

If a bidder provides a bid guarantee from a foreign bank (outside Djibouti or Saudi Arabia), this must be accompanied by an agreement signed between the guarantor and a bank established in Djibouti or Saudi Arabia. Bidders will remain bound by their offer for a period of one hundred and twenty (120) days from the deadline for submission of bids.

Tenderers must have the necessary references and technical and financial capacity to carry out activities similar to those covered by the contract, as specified in the tender documents (see tender documents for details). Qualification requirements are:

- have achieved over the last five years (**2018, 2019, 2020, 2021 and 2022**) or (**2019, 2020, 2021, 2022 and 2023**) an average annual turnover from commercial activities of an amount greater than or equal to : **FIVE MILLION (5,000,000) USD** or **Eight hundred and ninety-five million (895,000,000) DJF**
- have achieved over the last five years (**2018, 2019, 2020, 2021 and 2022**) at least **two (02)** similar projects, each covering a total **gross surface area** of at least **2000 m²**.

Bidders will remain bound by their offer for a period of one hundred and twenty (120) days from the deadline for submission of bids.

8. This invitation to tender is subject to the laws and regulations in force in Djibouti, as well as the directives of the Saudi Fund for Development (SFD).
