Saint Vincent and the Grenadines has received financing from the Saudi Fund for Development toward the cost of the **construction of a health centre in South Rivers** and intends to apply part of the proceeds toward payments under the contract for construction of a Modern Health Clinic on South Rivers.

The **Economic Planning Division** now invites sealed Bids from eligible Bidders for the **establishment of a primary care center in the South Rivers area, with a total area of (460 square meters), consisting of three floors, including supplying and installation of electrical and mechanical systems for the center building. The expected duration of the work is eighteen (18) months**
3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the Saudi Fund for Development procurement guidelines as well as the Government of Saint Vincent and the Grenadines Procurement Act of 2018 and is open to all Bidders as defined in the Procurement Regulations.
4. **The Call is open to all companies, however, a margin of preference of 10% is given to Saudi Arabian and Local Joint Venture.**
5. Interested eligible Bidders may obtain further information from **the Economic Planning Division** and inspect the bidding document during office hours *0900 to 1500 hours* at the address given below.
6. The bidding documents in **English** may be purchased by interested eligible Bidders upon the submission of a written application to the address below. The documents will be sent by **email**.
7. Bids must be delivered to the address below on or before **October 31, 2025, at 1400 hours (SVG local time)**. Electronic Bidding **will** be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below:
