Project: Procurement of Plant Design Supply and Installation for Overhead transmission line (SUR-1033)

Sector: Energy sector

Project Description: **The project “Expansion of Transmission and Distribution Systems Project” covers Engineering, Procurement and Construction of the Overhead transmission lines.**

Loan number: 1/846

The Government of Republic of Suriname has received financing from the Saudi Fund for Development (SFD) toward the cost of Selection of Expansion of Transmission and Distribution systems and it intends to apply part of the proceeds toward payments under the contract for Procurement of Plant Design Supply and Installation for Overhead transmission lines (LOT 2), Republic of Suriname, for the Contracting for the Execution of Works of the project. The objective of the assignment is to carry out Engineering, Procurement and Construction for Overhead transmission line.

The services are expected to cover 18 months period from the commencement date. It comprises of,

- Phase 1: Design/Planning – 4 months
- Phase 2: Construction – 12 months
- Phase 3: Commissioning – 2 months

The Ministry of Finance and Planning, through Project Implementation Unit (PIU) now invites eligible contractors to indicate their interest in providing the required services. Interested contractor should provide information demonstrating that they are fully qualified; have required qualifications and relevant experience to perform the Execution of Works. The selection criteria of the contractors will be based on the following:

- Organizational structure showing key departments to perform the required Engineering, Procurement and Construction for Overhead transmission line.
- The candidate has provided services in at least two contracts within the last six (6) years, each with a budget at least value of at least USD 12,000,000.00 (Twelve MUSD), that have been successfully and substantially completed and that are similar to the proposed Plant and Installation Services.
- The candidate to have at least 10 permanent staff working for the candidate in fields related to the contract.
- The average annual turnover of the candidate for the last five years must be at least USD 29,000,000.00 in HV (≥ 110 kV) overhead line.



Contractors may associate with other firms to form a joint venture or sub-contractor to enhance their qualifications. The bidder must clearly indicate the type of intended association as joint venture or sub-contractor and the lead firm in the bid.

A contractor will be selected in accordance with International Competitive Bidding method with the procedures set out in the Guidelines for the Use of contractors under Saudi Fund for Development Financing. Contractors may express interests in the forms of association, validated by an agreement among members of the association, which clearly specifies the type of association, i.e. a joint-venture, intermediate forms of association, or sub-contractor. The Call is open for: Saudi Arabian firms or a joint ventures (JV) with Saudi Arabian firms.
